

# FREQUENTLY ASKED QUESTIONS (Updated Nov 13, 2025)

### 1) PRE-REGISTRATION

All Attendees wishing to either attend the Annual meeting or receive a copy of the meeting recording are asked to pre-register in advance no later than Tuesday November 18, 2025, at 12noon.

Exception: Current Board Members and Staff and confirmed nominees for board positions have all automatically been registered as an attendee.

### 2) ZOOM DETAILS

A zoom conference invite (or email) will be sent to all registrants, board members, staff, and nominees. You will also receive a meeting reminder with Zoom details one hour before the meeting starts.

In-Person Meet and Greet: Nov 19, 2025. 6pm Start
Annual General Meeting Start-time: Nov 19, 2025. 7pm Start

Zoom details will <u>not</u> be public or added to the MCA website. Those who plan to attend will be sent a calendar request via email with the zoom link.

If you have issues logging in or you cannot find details prior to the call, please text Penny Seier

204-612-5814. Please provide your name in the text and a brief description of the assistance you need.

**Please log-in 5-10 mins before the meeting starts** so we can sort any technical issues and be ready for a 7pm start.

There will be a brief wait when you do log in. We will be admitting all registrants from the Zoom Conference "Waiting room."

Once admitted please ensure you are on Mute to avoid any background noise.

If joining virtually please join us visually if possible (camera on) and add your name and club name to the description box.

## 3) MEETING DOCUMENTS

The meeting documents will be added to the MCA website event calendar. Annual reports will also be posted to the MCA website post AGM.

During the meeting there will be a power point presentation which will summarize the documents you receive and the motions that need to be approved. Please refer to the attachments sent in email (or posted to the website) for additional background and detail as needed.

### 4) MOTIONS & VOTING

Please note that you must be a 2025 (Individual) Member of the Association to be eligible to vote.

There will be five (5) Motions that will require approval from membership.

- Motion #1: Approve Agenda
- Motion #2: Adoption of Meeting Minutes from previous AGM (2024)
- Motion #3: Approve Audited Financials
- Motion #4: Approve Auditor
- MCA Board of Director Elections (a vote will be required if there is more than one person running for the position.
- Motion #5: Adjourn Meeting
- The chair will ask for a motion from "the Floor." Member can raise their hand to motion or go off mute to make the motion.
- All Motions require a "seconder" Member can raise their hand to motion or go off mute to second the motion.
- If there is opposition to the Motion, a member will unmute or use the Chat for further discussion or comment. If all in favour Motion carried.
- POLLING BUTTON: "Members" will be asked to vote if there are two or more people running for board positions. If there is a tie, there will be a re-vote. Members attending in-person will complete a paper ballot. Members attending will vote electronically.

## 5) ASKING QUESTIONS: ZOOM CONFERENCE "CHAT" and "HAND RAISE"

A board member will be monitoring Zoom for questions/comments and will interrupt the speaker to raise any questions you pose. You can share your question with "everyone" or message a specific board member "privately." If additional clarification is needed members can also "Unmute" for further discussion.
